Know the Law About Contracts Between Parents and Child ...

contract, "You must give me reasonable notice before you remove your child from my care" "Reasonable notice" is an unclear time frame - you may think reasonable notice means one month, but the parent may think it means two weeks A court would like rule in the parent's favor over this disagreement If
